NOISE: KEEPING IT DOWN AT HOME



We live in a noisy world. Every day, we hear a variety of sounds ranging from the soft hum of a refrigerator to the blaring siren of a fire engine. While we can filter out unimportant sounds and only focus on the sounds we need to respond to, more noise pollution occurs as our world gets louder.

Music concerts and noisy crowds are not the only cause of noise pollution. We can also blame the more obvious culprits such as televisions, hairdryers, vacuum cleaners, barking dogs, crying children, lawnmowers and traffic. Most household sounds keep safe noise levels. However, the problems begin when we operate several noisy devices simultaneously or raise the volume on the television so that we can hear it over the vacuum cleaner. When we take these actions, we raise the overall noise level in our homes without realizing it.

According to the Centers for Disease Control and Prevention (CDC), hearing loss is the third most common chronic physical condition in the U.S. and is twice as prevalent as diabetes or cancer. Approximately 40 million Americans have hearing loss, 10 million of which are attributed to Noise-Induced Hearing Loss (NIHL). NIHL is progressive, permanent and typically painless. It is also the only type of hearing loss that is 100 percent preventable!

What is NIHL?

Sound is measured in units called decibels. Sound waves deliver decibels to sensory hair cells in our ears, which allow us to hear. Because people can't hear all frequencies or pitches of sound, A-weighted decibels (dBA) can be used to describe sound based on what human ears can hear. For example, a whisper measures 30 dBA while a normal conversation measures 60-70 dBA. These sounds are considered safe. When sound is at or above 85 dBA (e.g., lawnmowers, city traffic, chainsaw) for too long, it can damage the tiny sensory hair cells in our ears, causing hearing loss.

The American Academy of Audiology estimates that one in eight children has sustained NIHL and 16 percent of teenagers have sustained NIHL due to prolonged exposure to personal listening devices.

Because hearing loss can affect a child's ability to develop communication, language, and social skills, early preventative measures, hearing testing, and education about NIHL for adolescents are helpful to overall hearing health in the future. Miami-Dade County Public Schools (M-DCPS) has mandated hearing screenings for students in kindergarten and grades one and six. However, parents are encouraged to speak to their child's pediatrician about audiometric screenings that detect NIHL.

Each year, the World Health
Organization designates March 3rd
as "World Hearing Day" to highlight
the increasing number of people
living with hearing loss. M-DCPS, in
collaboration with Ear Peace Save
Your Hearing Foundation, launched
a districtwide campaign to promote
awareness of this initiative. The goal
is to bring understanding about the
effects of NIHL and provide resources
on topics such as protecting your
hearing, identifying the early signs of
NIHL, and information on diagnostic
testing if hearing loss is suspected.

GIVE YOUR CHILD A HEAD START



The Miami-Dade County Public Schools (M-DCPS) Head Start and Early Head Start program is accepting applications for children ages two (2) months to four (4) years of age to participate in the 2022-2023 program year.

The Head Start/Early Head Start program is provided in partnership with Miami-Dade County Community Action and Human Services
Department and is a federally funded, comprehensive child development program for income-eligible children who reside in Miami-Dade County.
Children between the ages of three (3) to five (5) may participate in the Head Start program, enrolling as soon as their third birthday. Early

Head Start serves children ages two (2) months to three (3) years of age. Children with disabilities are included in the program and receive a full range of developmental services.

Families are encouraged to apply online by visiting headstart. dadeschools.net. Families may also contact their nearest school to obtain information on the program, including eligibility criteria and application procedures. THE REAL COST OF FAKE IDS



Did you know? Manufacturing, possessing or displaying a fraudulent ID card is a third-degree felony under Florida law. Florida statute 322.212, Unauthorized possession of, and other unlawful acts in relation to, driver license or identification card, defines state provisions related to the illegal use of driver licenses and identification cards (IDs) and codifies penalties associated with the violation of these provisions. The penalties are severe and can have

lasting negative effects on those who face them.

The price you may pay:

- Up to 5 years in prison
- \$5,000 fine
- Between \$2,500 and \$7,500 in attorney fees plus court costs
- Someone can steal your identity
- May affect your current and future education
